

SIGNATURE REQUIRED

LEAD SERVICE LINE REPLACEMENT AGREEMENT



Approved contractors will be working in the Village to replace service lines classified as lead. This is in compliance with the Michigan Lead and Copper rule. Under this rule, if your home has a service line classified as lead, you are eligible to have it replaced, at the Spring Lake Water Department's expense.

The following terms and conditions apply:

THE OWNER/OCCUPANT(S) UNDERSTANDS AND AGREES AS FOLLOWS:

1. I/We, the undersigned Owner/Occupant(s), grant permission to the Village of Spring Lake's Department of Public Works and its representatives or approved contractors, to enter upon the premises to replace the existing private portion of the water service line which extends from the curb stop at the property line to the water meter which will be located within the premises (hereinafter referred to as the "project").
2. In order to complete the project described in paragraph 1, I/we agree to allow the Village of Spring Lake's Department of Public Works and approved contractors access to the existing water supply system, the existing driveway, lawn areas, and basement or meter area, as needed until the work is complete.
3. Upon completion of the project, the Village of Spring Lake shall restore the premises as follows:
 - a. All established lawn area that is damaged as a result of the project will be repaired with topsoil, seed and mulch.
 - b. Any portion of the existing driveway damaged as a result of the project will be repaired and restored with like materials and to matching thickness.
 - c. The approved contractor and DPW staff will do their best effort to preserve any trees or other landscaping.
4. I/We understand and acknowledge by signing this agreement that replacement of the private water service line, as identified in paragraph 1, does not constitute any further responsibility of this private water service line by the Department of Public Works and approved contractor. The private service line and interior plumbing remains the private property of the Owner and continues to be the full responsibility of the Owner at all times now and in the future.
